Texas A&M AgriLife Extension Service Programs for Minors Compliance Requirements

Texas A&M AgriLife Extension has designated two levels of Programs for Minors activities. If you are not certain of where the program fits, please consult your District 4-H Specialist and/or Dr. Darlene Locke.

Level 1: Lower risk – some examples include but are not limited to day camps, workshops where a speaker is heard, chartered club and/or project meetings/practices, arts and crafts, low impact play, and hosting school field trips; *parent/legal guardians or their designee and/or teachers are present*.

AgriLife Extension employees or their designee do not serve as chaperones and do not have full supervisory responsibilities. Adult: youth ratio 1:25, noting no adult should be 1:1 with a youth.

Note: Supervisory duties of youth participating in a chartered 4-H Club and/or Project meeting are the responsibility of the Parent/Guardian or their designee.

Level 2: Moderate to higher risk – may include but are not limited to events with one or more overnight stays, programs with a moderate level of physical activity, transporting youth domestically, out of state, or out of country; parent/guardians are not present, and Extension has full supervisory responsibility.

Adult: youth ratio 1;8, noting no adult should be 1:1 with a youth.
